The majority of our hospitals and care centers outperform state and national averages in nearly every measure of healthcare quality — ultimately helping patients get healthier faster and lowering the total cost of care.



#### RANKED AS DELIVERING HIGH QUALITY CARE

### TOP NATIONAL SYSTEM:

IBM Watson Health recognized Sutter Health as being among the top-performing, 26 large health systems in the U.S. in 2021. This recognition considers superior performance on quality, patient satisfaction, cost per episode of illness and operational efficiency.

### CMS STAR RATINGS:

Sutter hospitals earn an average of 3.76 out of 5 stars from the Centers for Medicare and Medicaid Services, above the national average of 3 stars. Seven Sutter hospital campuses received 5-star ratings and an additional four hospital campuses received 4 stars.

### U.S. NEWS BEST HOSPITALS:

U.S. News & World Report recognized 15 Sutter hospital campuses for providing high quality healthcare in its 2021-22 Best Hospitals list. Two Sutter hospitals also ranked among the top 50 and 100 in California.

### **EXCELLENCE** IN CARE:

In 2019 & 2020, the Integrated Healthcare Association awarded Sutter Medical Foundation – Sutter Medical Group the "Excellence in Healthcare" award, demonstrating performance that ranks in the top 50% for clinical quality, patient experience and cost for their commercial HMO population.



## HIGHER QUALITY CARE = HIGHER QUALITY HEALTH OUTCOMES

The unique connectivity of Sutter's system allows us to spread best practices, efficiencies and innovations across our network — directly resulting in enhanced healthcare.



#### **CANCER CARE:**

Sutter's 13 Comprehensive Cancer Centers and 25 infusion locations are accredited by the Commission on Cancer — indicating high performance in cancer screening for breast, cervical and colorectal cancers and placing these facilities in the top 10% of hospitals in California and nationwide for early detection that is key to treatment.



#### COVID-19:

Sutter reduced hospital length of stay for COVID-19 patients from 20 days at the start of the pandemic to 8 days by the end of 2020.



#### **SEPSIS PROTOCOL:**

By implementing a systemwide sepsis protocol, Sutter annually decreased the mortality rates for patients diagnosed with sepsis or septic shock during the past five years prior to the COVID-19 pandemic.



#### **C-SECTION RATES:**

Among the lowest in California and nationally (21.2%) for low-risk, first-time moms with normal pregnancies across all race/ethnic groups.



### MATERNAL DATA CENTER EARLY IMPLEMENTER AWARD:

Only California health system to win an award recognizing outstanding achievement in 2020.



## SUTTER RESEARCH: BRINGING DISCOVERIES TO LIFE

Researchers at Sutter work every day to deliver new solutions and advanced treatments to our patients. In 2020, Sutter invested more than \$60 million in research and development to help pioneer breakthroughs in healthcare delivery. These investments include offering our patients access to more than 150 clinical trials to address a wide range of health concerns including COVID-19, stroke, cancer, Alzheimer's disease, multiple sclerosis and more.



# DESIGNING INNOVATIVE CARE MODELS

#### **PROGRAMS SNAPSHOT:**

**SCALING TELEHEALTH FOR THE LONG TERM:** In 2020, Sutter rapidly expanded telehealth — scaling to train more than 5,000 clinicians and serve 1 million+ patients.

· Based on recent survey data, 96% of patients report a positive experience.

**DESIGNING INTERVENTIONS TO ADVANCE HEALTH EQUITY:** The health equity team developed an asthma program to address the needs of Black patients who sought care through the Emergency Department. The culturally competent initiative provides patients with group classes, home and virtual visits and medication management support.

• Since its launch, nearly 600 Black patients suffering from asthma have participated in the program with very few returning to the ER after joining the program.

**LAUNCHING SCOUT BY SUTTER HEALTH:** A new non-clinical, virtual program, Scout combines human and digital components to support youth ages 12 to 26 years old who experience anxiety or depression.

- · More than 700 youth and caregivers served in the first year.
- In a 2021 survey of 127 participants, 95% of users found Scout content meaningful, and after 12 weeks, youth reported a 20% improvement in self-perception of mental health.

2020 represented a challenging year on many levels, but Sutter's frontline staff and clinicians continued to be there for our patients — delivering quality care and providing a positive patient experience.
